

2026 FAIRHAVEN HOMECOMING DAY FAIR VENDOR APPLICATION

Saturday, June 27, 2026 | 10:00 a.m. – 4:00 p.m.

RULES AND REGULATIONS

- There are **no refunds for any reason once accepted**, including weather cancellations or vendor withdrawal. There is **NO rain date**.
- **Application deadline:** April 3, 2026. A **\$25 late fee** applies to any application post marked after this date.
- Application fees are deposited upon receipt but **do not guarantee acceptance**. If your application is not accepted, your fee will be refunded.
- Vendor acceptance letters will be emailed **on or before April 30, 2026**. To receive a copy by mail, include a **self-addressed, stamped envelope** with your application.
- \$50 per booth – Churches, Schools, Civic Organizations, Nonprofits
\$100 per booth – All Other Vendors
- Nonprofit vendors must check the box below and **submit supporting documentation** to qualify for the nonprofit rate.
- Applicants must be **18 years or older**. Children and students are welcome to work under adult supervision.
- **All items sold must be handmade** by the vendor. No imported goods, copyrighted images, flea market items, antiques, political materials, or unapproved literature.
- **No raffles/drawings/auctions** are allowed. General information brochures must be pre approved by committee.
- **Food vendors** must obtain a permit from the **Fairhaven Board of Health** at least two weeks prior to the event.
- Each booth space is **10' x 10'**. All equipment (including tables, tents, displays) must fit within this space and use **straight tent poles**. This is a street fair, and trees line the streets — plan tent height accordingly.
- Vendors using vehicles or trailers must **list dimensions**. Anything over 10 feet requires **two booth spaces**.
- **Generators** must be approved at time of application. Electricity is NOT readily available.
- **Setup begins at 6:30 a.m.** no earlier. All vehicles must be off the grounds by **9:00 a.m.** and may not return until **4:15 p.m.**
- Booth breakdown begins at **4:00 p.m.** (no earlier). Vendors are responsible for **cleaning their space completely**.
- Vehicles may only enter the fairgrounds through the designated **check-in entrance**.
- **Noncompliance may result in disqualification from future events.**

AGREEMENT

I have read and agree to the 2026 Fairhaven Homecoming Day Fair Rules and Regulations outlined above, sponsored by the Fairhaven Improvement Association, a 501(c)(3) charitable organization. I understand that once accepted, the entrance fee is non-refundable for any reason. Submission of this application does not guarantee acceptance; confirmation will be sent via email. Incomplete applications or those submitted with insufficient payment will be returned. I understand that failure to comply with the stated rules and regulations may result in disqualification from future events.
